The data we hold, including medical reports, will be held electronically and / or in a manual filing system.

RAM will only send your data within the United Kingdom, European Economic Area (EEA), the Channel Islands and the Isle of Man and only store your data in the United Kingdom, & the European Economic Area (EEA).

Although RAM will only send your data to a business within the areas mentioned, that business may operate globally and may transfer your data for operational purposes within their organisation or to a third-party service provider. These global businesses are obliged however to put in place appropriate safeguards (contractual commitments) in accordance with applicable legal requirements to ensure that your data is adequately protected outside the United Kingdom and Economic European Area (EEA).

What is your information used for?

The legal basis for the processing of the information provided to us is in our legitimate interest, to enable you or your employer to enter into a contract for a Group Risk contract and for the ongoing proper administration and performance of the contract.
